

Rentals of the Pedro Point Firehouse during Covid-19 Pandemic

The Pedro Point Community Association is allowing rentals of the Firehouse with some restrictions. Here are the San Mateo County guidelines.

Small private gatherings are allowed outdoors and indoors with modifications.

- Masks and physical distancing required
- No more than 3 separate households may attend (including the host's)
- Gatherings should be 2 hours or less
- Those with symptoms of illness must not attend
- Those at high risk of severe illness strongly encouraged not to attend
- Singing, shouting, chanting, cheering, or exercising strongly discouraged outdoors and not permitted indoors

Our priority is the safety of our community and the attendees of rental events during this public health crisis. State and county health and safety recommendations will be followed for every rental.

- All events must abide by the guidance of San Mateo County at the time the event is held.
- The PPCA reserves the right to refuse rentals.
- Cancellations due to changing pandemic public safety rules will be allowed and refunds will be issued. Events which violate public health guidelines may be immediately cancelled and deposits forfeited.

II. Approval of Oct. 15, 2020 Minutes—Breck moved, Marcia seconded to approve

III. Seating of New PPCA Board Members and Treasurer Chloe Wixsom

All officers were nominated for two-year terms in Jan. 2020 except the Treasurer Breck Hitz, who requested a one-year term. We now have the maximum number of board members at 12. Motion to accept nominations of new Board of Directors and Treasurer Chloe Wixsom passed unanimously.

IV. Treasurer's Report Balance Sheet, Income & Expenses through 12/31/2020

Breck presented Treasurer's Report. Due to lost of Firehouse rentals during the pandemic, we have had net operating income of -\$7,500 in 2020.

Over the years, we have been saving for the substantial funds required to repair the south wall of the Firehouse, which is plaqued with dry rot. We should be financially solvent through another year of the pandemic, but will face more problems financing much-needed repairs in the long-run. What has been done to reduce expenses: unplug freezer, fridge, cancelled trash pickup service. Confirmed we can accept non-tax-deductible donations online through PayPal or through checks. Does PPCA qualify for PPP loans? Breck, Chloe, and Bruce will discuss. Motion to accept Treasurers Report was passed unanimously.

V. Committee Updates

Firehouse Committee - The need to replace outside siding persists, but we still need more funds.

Ed (Joanne's husband) has offered to shadow Danny as the Firehouse Liaison in training

Firehouse maintenance continues during the pandemic downtime for the Firehouse. A cracked strut in the ceiling joist system was replaced in December. Recently Dwain Coggins made a generous donation of acoustic paneling material that was to be installed in the Firehouse to improve the acoustics. The project unfortunately didn't happen but the acoustic panels were sold and the revenue was donated to the PPCA general fund.

Trash: There has been a lot of trash lately in front of the Firehouse. The City used to be in charge of emptying the trash can in front of the Firehouse, which was transferred to Recology. Camille will contact Recology regarding their obligation to pick up the trash in front of the Firehouse.

Pedro Point Shopping Center: The increase of takeout during COVID-19 has resulted in trash throughout the neighborhood, especially in the field, which no longer has a trash can. Businesses in Pedro Point do not have adequate trash receptacles. Camille will contact Councilmember Sue Beckmeyer.

VI. New Business

Outreach: We will no longer be printing paper copies of the newsletter. Marcia put postcards in the boxes of every single person who still receives a paper copy of the newsletter and only one person wanted a printed copy.

Breck has registered the Firehouse as Red Cross Disaster Preparedness Site. Chloe will help with social media. Event Committee: Discussed continued need to connect during this pandemic. A virtual wine tasting with Table Wine and restaurant was suggested but no interest. Drive-through movie: This event sells out every time it is in Pacifica. In August, the PPCA, with Beach Break Entertainment, reached out to the owners of the field using the same email address when Mr. Calson, the owner, served on the PPCA board. We never heard back. We have followed up with the Pacifica Planning Department and Sue Beckmeyer, since they seem to be in frequent contact with Mr. Calson. There was no

Coastal Commission Ruling on Local Building Permit

Recently, the California Coastal Commission unanimously voted to deny the application of a local Pedro Point property owner seeking to expand the scope/scale of a proposed development project on San Pedro Ave. (ie: adjacent to the Pedro Point Field next to the Grocery Outlet parking lot) The project was denied based on potential Coastal Act violations, the presence of wetlands, environmentally sensitive habitat, (i.e. California Red-Legged Frogs), as well as the potential for coastal hazard impacts over time. Individual commissioners noted they liked the concept of the proposed development, but couldn't get past the conflicts with environmental factors and the presence of endangered species.
