A fabric that cloaks us all whether we know it or not.

## PPCA MINUTES, JULY 21st, 2011

PPCA MINUTES for JULY 21, 2011

Meeting called to order at 7:45

Present: Estrella, Settel, Ferry, Casillas, Martin, Holler, Hitz Absent: Jaquith, Clark

- 1. Minutes of last meeting and treasurer's report approved.
- 2. Pacifica Parents Group reported on progress towards new playground. Their goal is to raise \$15,000 and to build next year.
- The Firehouse Manager also reported that neither the city nor Recology will take responsibility for emptying the trash can outside the Firehouse. Councilman Jim Vreeland said he would talk to Recology about the situation.
- 4. Jim also reported that the San Mateo Transportation Authority had authorized \$360,000 in funds from Measure A for securing property to develop Headlands trail access. This had been matched by a promise of \$250,000 from the Coastal Conservancy. Money is still needed for construction of trails and the trails must be built before the transfer to GGNRA can be completed. The current plan is to build a disability-accessible trail east of Ace Hardware. Negotiations are continuing with property owners to allow that to happen.

Discussion are also going on with Caltrans in an at-

- tempt to get the property in front of Fresh and Easy to be some kind of trailhead, with tables or an information kiosk. The idea is to build a continuous trail to Montara.
- 5. The major discussion of the evening was the draft Pacifica General Plan which contains a re-zoning of the Calson property to allow for medium and high density residential multifamily housing with a park. There was general agreement that this was not what we at the meeting want to have happen with the property. The public comment period on the plan is open until August 12th and it was the sentiment of the meeting that the community should respond with its recommendations for the zoning for that property. A meeting was scheduled for July 26th to develop a responsive statement which would then be sent out to the community for e-mail comment.
- Upcoming events were discussed, including the Chili Feed, the movie "Last Train from Bay Meadows", the Fog Fest, and a possible Moveable Feast at the end of October or beginning of November.
- 7. New Business at the meeting was mention of the need for restricted parking at the firehouse in order to allow for trucks to load/unload for events.
- 8. Meeting adjourned at 9:10.

### PACIFICA GENERAL PLAN UPDATE FOR THE PEDRO POINT AREA

Over the past year the city of Pacifica has contracted with a team of consultants who have held public meetings to gather input on a plan for development in the city. The General Plan Update (GPU, http://www.cityofpacifica.org/depts/planning/general\_plan\_update\_project/default.asp) includes comments for the Pedro Point community, specifically the property located along San Pedro Ave roughly between Danmann and Grand. The property encompasses approximately five acres. The property was purchased by Ron Calson 15 years ago. At that time it was zoned commercial. Mr. Calson has not presented any plans for development of this property.

Within the GPU the consultants proposed several possible developments for the field including A) Commercial/Residential, B) Hotel/Commercial/Mixed-Use/Residential or C) Hotel/Mixed-Use. The City Council rejected the idea of all the above, but said they may consider very low density residential. Several council members were in favor of the proposed new alternative of Commercial-recreational. Mr. Calson has made it known that he has rejected the commercial, hotel, mixed use and high density residential, but is actively proposing re-zoning as Residential. Recently a committee from the Pedro Point community gathered to discuss what alternatives could be for this property considering the impacts of residential development and the interests of the Pedro Point residents. Discussion included the results of a survey conducted in the Pedro Point community and current considerations of population density, traffic flow and demographics. An important question raised is: what zoning makes sense for Pacifica's long-term economic stability and the integrity of the neighborhood – which means should it remain "commercial", or a modified version of "commercial" (commercial-recreational) or a different land use (residential, open space)? The position made by the PPCA in a letter to city council submitted for the August 12 council meeting stated: PPCA strongly opposes any re-zoning of this site as Residential, Hotel or Mixed-Use. The "Commercial-Recreation" zoning subclass proposed in the GPU update ensures a reasonable economic use of the field by private owners, while retaining some of its open space public benefits, such as flood detention capacity. Some examples of development under the Commercial/Recreation zoning include:

- bike rental, kayak rental, beach equipment rentals
- horseback riding
- pony ride/kids play park (like Lemos Farm in Half Moon Bay)
- expansion of outdoor social event space (to complement the firehouse) ie: Gazebos and decking for receptions & picnics
- Local exotic plant nursery & gardens
- Carousel & playground
- outdoor event space for beach festivals, surf competitions etc. (to complement the PPCA Firehouse)

The field is a lowland: all street runoff from the hillslopes drains to it, which is why it acts as a flood basin during rain-storms...a sponge for all the surrounding residential areas that hosts numerous snakes, frogs, and birds. It is a non-tidal wetlands area as designated by the U.S. Fish & Wildlife Service (USF&WS). Adjacent properties may be placed at increased flood risk if more impervious surfaces are added, and flood detention capacity is removed. Backwater flooding at the mouth of San Pedro Creek during extreme high tides and flood peaks makes the flood basin very important as a safety valve for all neighbors bordering the field. Regarding Flooding/run-off: Any significant increase in impervious surface area in the field – rooftops, driveways, roads – will add to runoff, and reduce the area runoff & rainfall may spread out during storms (flood detention capacity). On Monday October 10, 2011 the Pacifica city council discussed the rezoning of the Calson property. Many Pedro Point residents attended this meeting and several expressed their opinions about rezoning of this property. Councilmember Jim Vreeland recommended to table the vote until the Council, the Planning Commission, and representatives from Pedro Point could meet further.

This issue will be on the agenda for the next PPCA general meeting.

## Big Changes at the Headlands

If you have walked the Pedro Point Headlands recently you have probably notice a few more changes:

- Pampas Grass and French Broom which used to be so prevalent last year is mostly gone? Happily, due to the
  restoration team (including many PPCA members) with the help of Go Native (on the huge Pampas Grass),
  most of these invasive species have been found and removed. Constant vigilance is still needed to keep the
  new seedlings from developing but in most places, these species on the headlands have been eradicated.
- Water bars (angular ditches to divert water runoff from the trails) were installed last winter because of the heavy rainfall. We may install more and clean out some of the existing ones to further reduce erosion through this coming rainy season,
- Old slide on the south side of the trail from the green gate is devoid of trees and pampas grass and budding
  with red flags marking new native plants. We'll probably remove the flags this winter.
- Native plants are growing in the greenhouse for the new slide (December 2010). We plan to plant this area this winter.
- The green gate is no longer accessible due to Cal Trans installing an additional lane for two bus stops just north of the bridge entrance. Work is expected to go through October 15th. We will be making arrangements to have access to the headlands for our workdays.

If you would like to join us as we continue our restoration efforts on the headlands, please mark your calendar for our Charlie Brown Christmas Tree/garland/wreath event for Sunday November 27th.

No workdays in December but two in January (8th and 29th.) Whether you prefer to remove unwanted invasive plants that threaten the native species, tend the newly planted seedlings, clear water bars, or collect mature seeds for the eroded slopes we can use your help. There is a lot to be done on the headlands and it is quite fun working together to do it. Collectively we learn and teach each other about the plants, birds, and natural history and have a lot of fun. Please do join us if you can and bring the kids!

Please meet us at the Pedro Point Firehouse (Dannmann road) at 9:45 am. We will load up the cars with tools and carpool to the headlands. If you have any questions or to RSVP for large groups, please call 415-309-5856. Otherwise, simply bring your friends and family and be prepared to have fun! Please wear long sleeves, long pants and sturdy shoes. Bring reusable water bottle and gloves if you have them.
